FVPSA Contract Updates

• The FFY26 FVPSA Application was submitted. Next year, feedback will be solicited from the providers prior to submission.

- Last year the application was due by March 31, this year it was due by January 31. We worked to input data and components about underserved communities and who we are serving. We also sent it to our legal dept to review it before submitting to ACF. All states are in the same boat regarding policies, but we will wait to hear their feedback and go from there. Unfortunately, everything is very vague and broad at the federal level right now, so we are working on figuring everything out.
- We always run about the same amount of funding and at this point, we have no new news to the group on DVSS funding we don't know what is going to happen at the federal level. There is General Revenue (GR) funding in the budget for VOCA, but we will communicate with agencies on this. In the future, we will have the agencies review the FVPSA Application for feedback before DSS submits.
- ARPA Funds end Sept 30, 2025.
