Comments/Questions:

Katie Dalton: What are the timeframes of the roundtable meetings? *Answer:* 9 am to 3 pm.

Amy Couture: Does this new great funding news mean that, if this all passes, then agencies might receive the same level of VOCA funding this year, instead of reductions? *Answer:* Yes, that is correct. If everything passes, that means no reductions.

Matt Stewart: Just making sure that i understood correctly, if the GR money stays the same as proposed now, then we can expect to stay level funded? Same was we were for this current year. Thank you.

Answer: Yes. As long as everything passes.

Patrick Foran: What does this mean for the new Fix VOCA Act? *Answer:* We don't know exactly what this means. We believe that it still has to be passed at the federal level.

Kelly Pedigo - Are we looking at a competitive bid if GR funding is approved and goes through? *Answer:* It will not be a full competitive bid. It will be a simple proposal. We don't know yet when it will be released. We hope to have it sent by the end of June/beginning of July. It will not be graded, just a proposal for us to have on file.

JADASA - What is the deadline for the proposal? *Answer:* It will be in September.

VOCA Agency Highlights -

- *Family Forward:* Annie Herz They work with children dealing with trauma, including early childhood trauma. They have prevention, foster care case management and licensing. They work with St. Louis City and County, as well as about 4 other counties. 4,098 clients last year. They have also launched a podcast to talk through things that children who have been abused experience.
- *Foster & Adoption Care Coalition:* Melanie Scheetz– They have a very collaborative community in STL. In Missouri, we are the top in the nation for children placed with family while in foster care. The Kinship Navigator Program is designed to help kinship placements navigate their way through the process including home visits, licensing, and developing a wraparound team to help support the children and the caregiver.
- SAWERRA Jay Sridhar –
- Life Source Consultants Not Present
- *McDonald CO Circuit Court.* Dana Works alongside the prosecutors office and sheriffs department. They have a special office for security for victims presenting with physical violence. They work with approximately 300 victims a year. It is court system based, including all things court based- testifying, notices, protection orders, etc. She will sit in on various meetings with victims and make referrals for several different services. They also have after hours protection orders.
- *MICA* Kenneth Migrant Immigrant Community Action Project in STL. They have a service areas of 150 miles. They assist with immigrant and legal services. They serve approximately 1,000 clients per year. They help with various services including case management and referrals. They help with victims of crime to get them to resources. They have a trivia night coming up in STL.
- *Mid Ozark CASA* Present but connection is spotty. Mid Ozark CASA news is that we just moved, yesterday, into our permanent office, after a fire in August caused us to move into 2 temporary places. We're very happy to finally be settled, however our some of our computers are not liking moving again, I apologize for the glitch.
- *MAPA* Jamie Padgett MOPS and MAPA. MAPA was developed to help give uniformity across the state for prosecuting attorneys. They developed a training council subcommittee in 1981, which is MOPS. All positions are with MOPS as the government agency. Kathleen's position is specific to VOCA. Any prosecutor across the state can call the general council and receive assistance. They work on many different kinds of cases. Specifically for VOCA, MAPA wrote for a passthrough grant and received funding for

advocates for prosecutors offices throughout the state. They collaborate with the Department of Public Safety for trainings and conference needs for advocates.

- North Central Mo Childrens Advocacy Center Verna Kelsey Agency works with child victims of abuse and conducts forensic interviews. They work with 10 counties in the rural area. They see approximately 200 new children every year, with about 200 on going cases each year. They provide case advocacy and support. All services are at no cost. They work with a MDT and hold case reviews. Due to the rural area, they have to search for resources. They conduct prevention education programs in the schools and community.
- St. Charles Family Court Not present
- **Douglas Community Services-** CASA program Emily Trevathan located in Hannibal. They serve the majority of the counties located in the NE region of the state. They have a housing/rental assistance program, utility assistance, toys for tots – 1515 kids through toys for tots, plus various other community projects. They have 17 CASA volunteers. Last year they served 40 kids, and 12 of them received permanency. Emily is now Safe at Home certified. They are in the midst of a capital campaign for a new building. The CASA program has a Care Closet for kids coming into care.
